#### Job Opportunity: Postdoctoral Researcher to Support RISE

The Colorado Lab seeks to add a postdoctoral researcher to support evidence-building among recipients of Response, Innovation, and Student Equity (RISE) Education Funds. To address the learning challenges related to the economic, social, and health impacts of COVID-19 and promote innovation, Colorado has awarded over \$40 million in RISE grants to educational institutions using federal Governors Emergency Education Relief Funds. The Colorado Lab is supporting 10 awardees in moving their programs along the steps to building evidence to support sites in successfully implementing and sustaining their projects, for example, by establishing implementation teams, clarifying intended outcomes and core components, and building a sustainable data infrastructure.

The position will support project leads in working deeply with RISE projects focused on K-12 career-connected learning, while building a portfolio of peer-reviewed publications under the mentorship of experienced Colorado Lab staff. The successful candidate will start as soon as possible with funding secured through June 2023 with the possibility of an extension based on funding.

#### Jeffco's Preventive Legal Services Pilot Program Launches

The Office of Respondent Parents' Counsel (ORPC) is accepting referrals for indigent parents in Jefferson County whose unmet legal needs may be affecting the safety of their children. The pilot program launches this month and aims to connect parents to preventive legal services and keep families together by addressing legal problems such as housing and eviction, custody and visitation, guardianship, parentage/paternity, and orders of protection. The goal is to safely reduce child welfare involvement and removals of children.

The Colorado Lab is working with ORPC to evaluate the pilot program in order to better understand its implementation and preliminary outcomes. Results and lessons learned will be used to inform program improvement in Jefferson County and potentially scale the program across the state.

#### Fostering Learning & Alignment Among DAs' Offices

The Colorado Lab is working with eight District Attorneys' (DAs) Offices in Colorado to develop data dashboards to assist them with tracking progress toward greater efficiency, effectiveness, and fairness. Last month, we facilitated the second cross-jurisdiction learning meeting with elected DAs and implementation leads from each pilot site. The meeting provided an opportunity for offices to hear from, connect with, and learn from each other.

Meeting participants dug into data-related challenges and opportunities, for example, working together to develop a shared definition of violent crime, identify a common set of disposition reasons, and brainstorm strategies to partner with law enforcement to improve the collection of defendant race and ethnicity information.

Each site shared and received feedback on their plans for community engagement, including defining the groups they want to engage with, the types of input and feedback they hope to gain from each group, and the strategies they will use to engage them. Data and community engagement go hand in hand.

By listening to the needs of the community, especially those who have been historically marginalized, prosecutors can learn what needs to be measured to fuel positive policy changes. By then returning to the community to keep them apprised of how their concerns were addressed, more trust and transparency is fostered, along with better outcomes for cases through increased witness/survivor participation.

#### Sara Bayless Named External Research Partner

A warm welcome to Sara Bayless as she partners with the Colorado Lab in support of our work with the Colorado Partnership for Thriving Families (Partnership). Dr. Bayless, who serves as a Director at the OMNI Institute, is skilled in conducting research and evaluation that helps organizations advance the evidence for their social programming.

The Partnership is a cross-system collaborative of human services, health care, and public health partners working together to significantly reduce child fatalities and child maltreatment for all

children ages 0 to 5 by supporting strong and healthy family formation. Recently, the Partnership was awarded a five-year Family Support Through Primary Prevention grant from the Children's Bureau. Dr. Bayless will support the Colorado Lab in building evidence for new primary prevention strategies funded under the grant in five demonstration counties, with the shared goal of promoting family well-being and preventing child maltreatment.

"At OMNI, we use research and evaluation to advance our understanding of how programs and policies can support families in developing their strengths and increasing their health, well-being, and economic security," Dr. Bayless said. "We are excited to partner with the Colorado Lab on this project to build evidence for how strengthening families can strengthen our communities."
